There are several distinct motivations potentially involved in compilation of reference lists.

Some people use them to impress the reader with the large number of things they have speed-“read” or at least listed.

Some people use them to ingratiate themselves with the people they have flattered by including.

In some contexts they provide a properly complete listing or review of the literature.

But here I am following what is common practice in scientific reports. Namely a minimal listing of those sources which provide significant support (or otherwise) for my own statements, or which the reader may find useful for further information. If I don’t provide a supporting reference for some particular statement, that is most likely because I reckon any doubter can easily enough confirm the matter for themselves anyway.
